NOTICE IS HEREBY GIVEN that the Applicant is requesting the Commission (a) issue an Order pooling interests and adjudicating the rights and equities of oil and gas owners in the Hunton common source of supply, underlying all or substantially all of Section 5, Township 14 North, Range 5 East, Lincoln County, Oklahoma, a 640-acre drilling and spacing unit to be established by an Order No. 544078.; (b) reserve the right to request the Order in this Cause be made effective on a date prior to the date of issuance; (c) name Applicant or some other party as Operator of the Unit Well of the separate common source of supply, and of the drilling and spacing unit therefore as a unit; (d) pool interests and adjudicate rights and equities in the Unit Well in the separate common source of supply, and in the drilling and spacing unit therefore on a drilling and spacing unit basis; and, (e) provide that the Applicant be given 365 days from the date of the Order in which to commence the Initial Unit Well.

IT IS ORDERED that this Cause be referred to an Administrative Law Judge for hearing, taking of evidence and reporting to the Commission.

IT IS ORDERED AND NOTICE IS HEREBY GIVEN that this Cause will be heard before an Administrative Law Judge on the Initial Hearing Docket at the Corporation Commission, Jim Thorpe Building, Oklahoma City, Oklahoma, at **8:30 a.m. on the 29th day of October, 2007**, and that this Notice be published as required by law and the Rules of the Commission.

NOTICE IS FURTHER GIVEN that Applicant and interested parties may present testimony by telephone. The cost of telephonic communication shall be paid by the person(s) requesting its use. Interested parties who wish to participate by telephone shall contact Applicant or Applicant's attorney, prior to the hearing date, and provide their name and telephone number.


