APPLICATION

Comes now the Applicant, Prize Energy Company, whose mailing address is 15 East 5th Street, Suite 1000, Tulsa, OK 74103; Telephone No. (918) 704-0478.

1. That the Applicant is the record owner of valid and subsisting oils and gas lease covering the lands described herein. The name and address of each party being made a respondent to this application are shown on Exhibit "A" attached hereto.

2. That Order No. 63238, dated the 20th day of July, 1966, established the Eola North Fault Block Oil Creek Sand Unit. That Order No. 63239, dated the 20th day of July, 1966, established the Eola North Block McLish Sand Unit. That Order No. 63240, dated the 20th day of July, 1966, established the Eola North Fault Block Bromide Sand unit. On the 29th day of March, 1989, the Corporation Commission by Order No. 337341 created one unit defined as the Eola North Fault Block Unit by consolidating the above mentioned Oil Creek, McLish and Bromide Sand Units. On the 29th day of July, 2004, the Corporation Commission by Order No. 492821 did amend and clarify the Eola North Fault Block Unit as said unit relates to the south boundary description of the Eola North Fault Block Unit.

3. That the Applicant alleges that the variables used to determine the lands comprising the unitized reservoirs defined in Order No. 63238, Order No. 63239, Order No. 63240, as amended by Order No. 337341 and Order No. 492821 did not include the limitation imposed on said lands and reservoirs resulting from the location of the North Eola Fault. However, this application for an order amending, clarifying and/or modifying Order No. 63238, Order No. 63239, Order No. 63240, as amended by Order No. 337341 and Order No. 492821, is filed to confirm that the location of the North Eola Fault separates the unitized reservoirs of the Eola North Fault Block Unit from the reservoirs that are not in the Eola North Fault Block Unit and that all horizons that have been or will be encountered north of the North Eola Fault are not included in the Eola North Fault Block Unit. The evidence, testimony and exhibits presented for the issuance of Order No. 63238, Order No. 63239, Order No. 63240, Order No. 337341 and Order No. 492821, have consistently shown this fault as the boundary for the unit set forth above. In support of this confirmation, the following Exhibit, as presented and made part thereof Order No. 63239, dated the 20th day of July, 1966, is attached:

5. That in accordance with the provisions of Title 52, Oklahoma Statutes 1973, as amended, Section 287.1 et seq., Rule 165: 10-5-4 [enhanced Recovery Projects], rule 165: 5-7-20, O.C.C.-O.G.R., the applicant is entitled to the order requested.

6. That in the interest of conservation, prevention of waste and the protection of correlative rights, and after proper notice and hearing as required by law and the Statutes of the State of Oklahoma and the rules of the Corporation Commission, the Commission shall issue an order confirming the named orders as requested above. The order to be upon terms and conditions that are fair, reasonable, equitable and which are necessary to continue to properly protect, Safeguard, and adjust the respective rights and obligations of all persons affected.

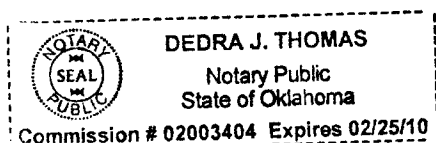

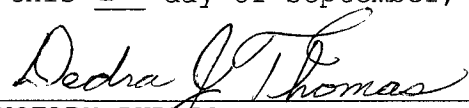
