I. Parties:

(a) The applicant, K. S. Oil Company, 5201 S. Western, Oklahoma City, OK 73109, Phone: (405) 634-5115, is the owner of oil and gas leases or the right to drill in the area involved herein. Applicant's attorney is Guy E. Taylor, 1616 E. 19th Street, Suite 304, Edmond, Oklahoma 73013-6627, Phone: (405) 341-5654.

(b) The respondents are those persons listed on Exhibit "A" attached hereto and made a part hereof.

2. Allegations of Fact: Heretofore, by Corporation Commission Orders No. 112492 and No. 258176, the NW/4 of Section 22, Township 7 North, Range 4 West, McClain County, Oklahoma, was established as a 160-acre drilling and spacing unit for the Misener-Hunton and Viola Dolomite separate common sources of supply, respectively. The Applicant or some other party is proposing to drill a well in said unit to test said common sources of supply. The estimated dry hole cost for the well to a depth sufficient to test the deepest of the named formations will be \$391,000 and a completed well will cost approximately \$646,575. The Applicant does not have leases from or agreements with the named respondents even though said Applicant has exercised due diligence in an attempt to locate each respondent and that as to those respondents who were found, a bona fide effort was made to reach an agreement with them as to how the unit would be developed.

3. Legal Authority: Title 52, § 86.1, *et seq.*, and the general and procedural rules of the Oklahoma Corporation Commission.

4. Relief Sought: The applicant, therefore, requests the Commission enter an order pooling the separately owned interests within the 160-acre drilling and spacing unit heretofore established by Orders No. 112492 and No. 258176 for the Misener-Hunton and Viola Dolomite separate common sources of supply, respectively, in the NW/4 of Section 22, Township 7 North, Range 4 West, McClain County, Oklahoma, and fixing and adjudicating the rights and equities of the owners thereof insofar as the right to drill and produce from said common sources of supply is concerned. The Order should also grant such further relief as in the premises may be reasonable and just. This should be considered a "unit" pooling rather than a "wellbore" pooling application with the rights of parties in subsequent wells drilled to the named common sources of supply to be determined by the order requested by this application. Further, Applicant requests that it or some other party be designated operator of said well.
