A P P L I C A T I O N

COMES NOW Applicant and shows the Honorable Commission as follows:

1. Parties: Applicant herein is **Canaan Resources, LLC.**, One Leadership Square, 211 North Robinson Ave., Ste N1000, Oklahoma City, OK 73102 (405) 604-9281. The attorney for the Applicant is Michael D. Stack, 3500 South Boulevard, Suite "D-5", Edmond, Oklahoma 73013; Telephone (405) 216-8898, Fax (405) 216-8321. The names and addresses of each person or governmental entity, other than the Applicant, currently having the right or claiming to have the right to participate in production from the Hartshorne common source of supply are set forth on Exhibit "A" attached hereto and made a part hereof.

2. Facts:

2.1 Applicant has the present right to drill in **Section 29, Township 8 North, Range 13 East, Pittsburg County, Oklahoma.** Said unit was designated as a **640 acre** drilling and spacing unit for production from the Hartshorne common source of supply.

2.2 There is presently a well producing in the Hartshorne common source of supply located in Section 29, Township 8 North, Range 13 East, Pittsburg County, Oklahoma.

2.3 Since the date of entry of the drilling and spacing unit additional or new data has been obtained in connection with the separate common source of supply sufficient to show a substantial change in conditions or change in knowledge of conditions existing in said unit. It appears that the existing well will not and cannot effectively and efficiently drain all of the primarily recoverable hydrocarbons in such separate common sources of supply underlying such land. Therefore, the Commission should increase the well density for the **Hartshorne** common source of supply as an exception to **Order No. 544573** for the drilling of three additional wells in **Section 29, Township 8 North, Range 13 East, Pittsburg County, Oklahoma.**

2.4 Applicant or some other party recommended by Applicant, requests the Commission to authorize and permit the additional three wells in Section 29 to produce hydrocarbons from the Hartshorne common source of supply, and the Commission should establish a proper allowable for such wells and such unit.

3. Legal Authority: Title 52, Sections 86.1, 87.1; Title 17, Sections 270 and 271; OCC-OGR Rule 165:10-19-3, OCC Rules of Practice.

4. Relief Sought: Applicant requests the Commission enter an order, to be effective as of the date of the execution thereof or as of a date prior thereto, authorizing and permitting three additional wells in the 640-acre drilling and spacing unit formed for the Hartshorne

common source of supply underlying Section 29. The Applicant further requests the authorization and permission to allow the additional wells to produce hydrocarbons from such common source of supply and to establish a proper allowable for said wells.

WHEREFORE, Applicant prays that, after notice and hearing as required by law, the increased well density as requested by Applicant, be permitted.
