COMES NOW the Applicant and shows the Corporation Commission as follows:

1. PARTIES: Applicant is LIMESTONE EXPLORATION II, LLC, c/o Jeremy T. Brannon, BRANNON LAND SERVICES, LLC, P.O. Box 7808, Edmond, OK 73083-7808, the owner of the right to drill a well to the common sources of supply named below underlying the lands described in the caption hereof by virtue of valid and subsisting oil and gas leases owned by Applicant covering portions of said land. 2. ALLEGATION OF FACTS:

(A) Applicant alleges that the Mississippian and Woodford are prospective common sources of supply underlying all of Section 12, Township 21 North, Range 3 West, Garfield County, Oklahoma and will be productive primarily of oil, that 640 acres would be appropriate size horizontal drilling and spacing units and that one well will adequately and effectively drain and recover the producible hydrocarbons underlying such area. That the depths at which Applicant expects to encounter said common source of supply in said area will be provided at the hearing.

(B) That the permitted well in the drilling and spacing units requested herein is necessary to effectively and efficiently drain the portion of the common sources of supply (reservoir) covered by such drilling and spacing unit, there being no existing well within the drilling and spacing unit which can effectively and efficiently drain the portion of the common sources of supply (reservoir) covered by such drilling and spacing unit.

(C) Applicant has conducted a diligent and meaningful search of the local county assessor's records, county treasurer's records, county deed records regarding the property involved for return addresses on recorded instruments, county probate records and city and county telephone and other sources of such information to locate the whereabouts and mailing address of each Respondent, or the identity, whereabouts and mailing address of Respondent's heirs, executors, administrators, trustee, successors, devisees or assigns, if any.

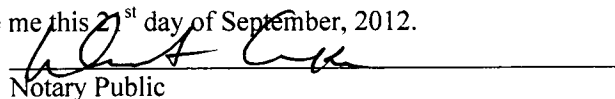

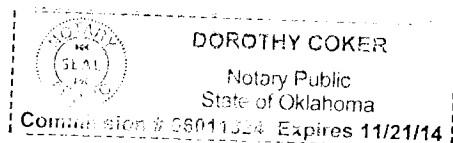
