COMES NOW Applicant and shows the Corporation Commission as follows

1. PARTIES: Applicant is **Newfield Exploration Mid-Continent Inc., 24 Waterway Avenue, Suite 900, The Woodlands, TX 77380**, owner of oil and gas leasehold interests within the lands described in the caption hereof. The name and address of each party entitled to notice of this Application is as shown on Exhibit "A".

2. ALLEGATION OF FACTS:

(A) The land described in the caption constitutes a "drilling and spacing unit", as defined by 52 Okla. Stat. § 87.1, and as established by the Commission by an order to issue in a companion spacing application for the Mississippian and Woodford common sources of supply; within said drilling and spacing unit there are two or more separately owned tracts or there are undivided interests separately owned for which the owners have not agreed to pool their oil and gas interests and to drill and develop the drilling and spacing unit and common sources of supply as a unit.

(B) Applicant has conducted a diligent and meaningful search of the local county assessor's records, county treasurer's records, county deed records regarding the property involved for return addresses on recorded instruments, county probate records and city and county telephone directories and other sources of such information to locate each respondent and has made a bona fide effort to reach an agreement as to the development of the unit with each respondent located by such search.

(C) Applicant has drilled or proposes to drill a well on said drilling and spacing unit to test the common sources of supply named below. That to avoid drilling unnecessary wells, prevent waste and protect correlative rights, this Commission should order all owners to pool their interests and drill and develop the drilling and spacing unit and common sources of supply as a unit, all to be upon such terms and conditions as are just and reasonable and which will afford all of such owners the opportunity to recover or receive without unnecessary expense their just and fair share of all hydrocarbon substances produced therefrom, and the Commission should make definite provisions for the payment of all actual costs and expenses, not to exceed reasonable costs and expenses of drilling and development, including a reasonable charge for supervision.


3. LEGAL AUTHORITY: 52 Okla. Stat. § 87.1.

4. RELIEF SOUGHT: Applicant requests that the Commission enter an order pooling the interests and adjudicating the rights and equities of oil and gas owners in the Mississippian and Woodford common sources of supply underlying Section 34, Township 7 North, Range 4 West, McClain County,

Oklahoma, and designating Applicant or some other owner of the right to drill as operator of the unit well. Applicant may request at the hearing that the order provide that any owner electing an alternative to participation in the well drilled thereunder shall be deemed to have relinquished all working interest and right to drill in the unit and common sources of supply named herein as to such well and any wells drilled subsequent thereto. Applicant may also request that the order to issue in this cause provide to the operator a period of one (1) year from the date of the order in which to commence operations for the drilling of the initial well proposed hereunder.


