**APPLICATION**

COMES NOW Applicant and shows the Honorable Corporation Commission as follows:

1. Parties: Applicant, TRP MidCon LLC, PO Box 79612, Houston, TX 77279, is the owner of oil and gas leasehold interests within the lands described in the caption hereof. The Respondents to this Application are shown on the Exhibit "A" attached hereto.

2. Allegation of Facts:

a. By the Orders to issue in Cause CD Nos. 201708351 and 201800467, this Commission will establish a 640-acre horizontal drilling and spacing unit for the Woodford common source of supply underlying Section 34, Township 7 North, Range 4 West, McClain County, Oklahoma.

b. The well pattern and density prescribed by said Orders are not adequate when taking into consideration the changed conditions which now prevail as compared to conditions known when such well pattern and density were first ordered. It is now necessary to drill three additional wells on said unit in order to effectuate the maximum recovery of hydrocarbons from said common source of supply. In order to prevent waste and protect the correlative rights of the parties in the reservoir, Applicant should be allowed to drill three additional wells on said unit.

c. There are two wells expected to produce from the above-named common source of supply located on the above described land.

d. The three additional wells requested by Applicant are necessary to effectively and efficiently drain a portion of the common source of supply (reservoir) covered by the drilling and spacing unit established by said Order which cannot be effectively and efficiently drained by any existing well within said drilling and spacing unit.

3. Legal Authority: Title 52, Section 87.1, O.S.


