APPLICATION

1. **PARTIES:**

Applicant is **BLACK MESA PRODUCTION, LLC**. Its address is 401 South Boston Avenue, Suite 450, Tulsa, OK 74103, **Telephone (918) 933-4454**. It is the owner of oil and gas leasehold interests within the W/2, SE/4, and S/2 NE/4 of Section 12, Township 1 South, Range 3 West, and the N/2 of Section 13, Township 1 South, Range 3 West, Carter County, Oklahoma. The parties being named as respondents to this application are set out on the Exhibit "A" attached hereto and made a part hereof.

2. **ALLEGATION OF FACTS:**

(A) The Corporation Commission has heretofore, in **Cause CD No. 201805991-T**, recommended an application to establish 880-acre irregular horizontal drilling and spacing units for the Sycamore, Woodford, and Hunton common sources of supply underlying the W/2, SE/4, and S/2 NE/4 of Section 12, Township 1 South, Range 3 West, and the N/2 of Section 13, Township 1 South, Range 3 West, Carter County, Oklahoma.

(B) The Applicant is proposing to develop the 880-acre irregular drilling and spacing unit consisting of the W/2, SE/4, and S/2 NE/4 of said Section 12 and the N/2 of said Section 13. At this time, the Applicant is intending to penetrate and/or evaluate the common sources of supply named hereinabove in the well proposed; intends to treat the common sources of supply in the pooling Order to issue herein as an aggregate; and, will seek an order pooling those separate common sources of supply as one pooled unit.

(C) The Respondents are the owners of oil and gas interests, or parties who claim to be such an owners, underlying the drilling and spacing unit described hereinabove with whom Applicant has been unable to enter into an agreement for the development of said unit; the sharing of the costs thereof; and the production therefrom. The Applicant has exercised due diligence to locate the respondents and has made a bona fide effort to reach an agreement with such respondents as to how the unit shall be developed, but has been unable to reach such agreement as of this time. 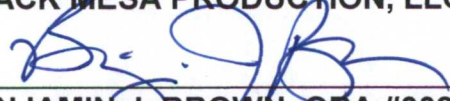
3. **LEGAL AUTHORITY:**

The relief requested is authorized by Title 52, Okl.Stat.Ann., §87.1.

4. **RELIEF SOUGHT:**

The relief requested is the pooling of all oil and gas interests in the Sycamore, Woodford, and Hunton common sources of supply for the 880-acre irregular drilling and spacing unit consisting of the W/2, SE/4, and S/2 NE/4 of said Section 12 and the N/2 of said Section 13, Township 1 South, Range 3 West, Carter County, Oklahoma, adjudicating the rights and equities of the oil and gas owners thereof and designating **Black Mesa Production, LLC**, or some other party as operator of the unit well. The Applicant shall request at the hearing that the order provide that any owner electing an alternative to participation in the well drilled thereunder shall be deemed to have relinquished all of its working interest and right to drill in the unit and common sources of supply named herein as to such well and any wells drilled subsequent thereto. In addition, the Applicant may propose that the order to issue in this cause provide a method for proposal of subsequent wells and for response to that proposal by owners who elect to participate in the initial well. At the hearing the applicant may request that the order to issue in this cause provide to the operator a period of one (1) year from the date of the order in which to commence operations for the drilling of the initial well proposed hereunder. The Applicant may propose that the requested order expressly authorize the drilling of multi-unit horizontal laterals under its terms, and that respondents may have the right to separate elections as to each common source of supply pooled herein if specifically requested. Further, Applicant may request that said Order be made effective on a date prior to its signing.
