RELIEF SOUGHT: HORIZONTAL DRILLING AND
SPACING UNITSLEGAL DESCRIPTION: SECTION 19, TOWNSHIP
19 NORTH, RANGE 7 WEST, KINGFISHER COUNTY,
OKLAHOMAAPPLICATION

COMES NOW Applicant and shows the Honorable Corporation Commission as follows:

1. Parties: Applicant is Chisholm Oil and Gas Operating, LLC, 6100 S. Yale Avenue, Suite 1700, Tulsa, Oklahoma 74136. The parties being named as respondents to this Application are listed on Exhibit "A" attached hereto and made a part hereof.

2. Allegation of Facts:

a. Applicant alleges that the lands in the caption hereof overlie the actual or prospective common sources of supply named below; that Applicant owns oil and gas interests in the area covered by this Application which entitle Applicant to drill for and produce oil and gas from the lands covered by the Application; that the protection of correlative rights and the prevention of waste require that proper drilling and spacing unit and well location be established therefore:

b. That a 640-acre horizontal drilling and spacing unit should be established for the **Mississippian (less Chester), Woodford and Hunton** common sources of supply as set out below.

c. That the permitted well in the drilling and spacing unit requested herein is necessary to effectively and efficiently drain the portion of the common sources of supply (reservoir) covered by such drilling and spacing unit, there being no existing well within the drilling and spacing unit which can effectively and efficiently drain the portion of the common sources of supply (reservoir) covered by such drilling and spacing unit.

d. Applicant has conducted a diligent and meaningful search of the local county assessor's records, county treasurer's records, and county deed records regarding the property involved for return addresses on recorded instruments, county probate records and city and county telephone directories and other sources of such information to locate each respondent.

3. Legal Authority: Title 52, Section 87.1, O.S.

4. Relief Sought: That Applicant requests that the Commission enter its order **extending Order No. 681210** insofar as it established a 640-acre horizontal drilling and spacing unit for the **Mississippian (less Chester)** common source of supply underlying Section 30, Township 19 North, Range 7 West, Kingfisher County, Oklahoma to include Section 19, Township 19 North, Range 7 West, Kingfisher County, Oklahoma; and **extend Order No. 684456** insofar as it established a 640-acre horizontal drilling and spacing unit for the **Woodford and Hunton** common sources of supply underlying Section 25, Township 19 North, Range 8 West, Kingfisher County, Oklahoma to include Section 19, Township 19 North, Range 7 West, Kingfisher County, Oklahoma. The Mississippian (less Chester) and Hunton common sources of supply are conventional reservoirs and for a conventional reservoir the completion interval of a horizontal well drilled in a horizontal well unit shall be located not less than 660 feet from any unit boundary. The Woodford common source of supply is an unconventional reservoir and pursuant to OAC 165:10-29-2 the completion interval of a horizontal Woodford well drilled in a horizontal well unit shall be located not less than 165 feet from any north/south unit boundary and not less than 330 feet from any east/west unit boundary.

Due to changes in technological development horizontal drilling is more economical and prevents waste and protects correlative rights. The horizontal well unit may exist concurrently with any previously formed non-horizontal drilling and spacing unit, or any part thereof, and each such unit may be separately developed in that a well may be drilled into, completed in and produce hydrocarbons from the same common source of supply in each such concurrently existing unit with production from such well to be governed by and allocated pursuant to the applicable unit. Therefore the following orders are not being vacated:

Order No. 98746 insofar as it established 80-acre laydown drilling and spacing units for the Mississippian common source of supply underlying Section 19, Township 19 North, Range 7 West, Kingfisher County, Oklahoma.

Order No. 113769 insofar as it established 80-acre laydown drilling and spacing units for the Hunton common source of supply underlying Section 19, Township 19 North, Range 7 West, Kingfisher County, Oklahoma.

Coastal Plains Energy, Inc. operates the West Hennessey 1-19 well, API No. 073-22610, located in the SW/4 SW/4 Section 19, Township 19 North, Range 7 West, Kingfisher County, Oklahoma which is producing from the Hunton and Mississippian common sources of supply.

5. Special Provision: The relief requested herein made be made effective prior to the issuance of this Order.

WHEREFORE, Applicant prays that after notice and hearing as required by law, the drilling and spacing unit as requested by Applicant, with appropriate well location and exceptions thereto, be ordered.
