APPLICATION

COME NOW the Applicants, 89 Energy II, LLC and ENECO, LLC, and show the Honorable Corporation Commission as follows:

1. Parties

a. Applicants are 89 Energy II, LLC, 105 N. Hudson Avenue, Suite 650, Oklahoma City, OK 73102. Applicants are the owners of the right to drill a well to the Caney, Sycamore and Woodford common sources of supply underlying a 640-acre horizontal drilling and spacing unit comprised of Section 7, Township 1 South, Range 3 West, Carter County, Oklahoma, by virtue of valid and subsisting oil and gas leases owned by Applicants covering portions of said land.

b. Respondents: The name and address of each party being made a respondent to this application is as shown on Exhibit "A" attached hereto and made a part hereof. If any named natural person is deceased, then the known or unknown heirs, executors, administrators, devisees, trustees and assigns, both immediate and remote, of any such deceased individual are made respondents herein. If any named respondent is a corporation, which does not continue to have legal existence and if any such corporation is dissolved, then the known or unknown successors, trustees and assigns, if any, both immediate and remote, of any such dissolved corporation are made respondents herein. Each of the named entities which is an unincorporated association is made a respondent if it continues to have legal existence and if any such unincorporated association is dissolved or otherwise not in existence, then the known or unknown successors, trustees and assigns, both immediate and remote, of any such dissolved unincorporated association are made a respondent herein. Any party designated as an executor or personal representative is made a respondent if presently acting in such capacity as such executor or

personal representative, and if such party is not presently acting in such capacity as executor or personal representative, then the known or unknown successor or successors to such executor or personal representative are made respondents herein.

2. Allegation of Facts:

a. Section 7, Township 1 South, Range 3 West, Carter County, Oklahoma, constitutes a "horizontal drilling and spacing unit," as defined by Title 52, §87.1, O.S., and is to be established by the Commission for the Caney, Sycamore and Woodford common sources of supply (640-acre horizontal unit by the Order to issue in Cause CD No. 201903484), constitutes a "horizontal drilling and spacing unit," as defined by Title 52, §87.1, O.S.; within said "drilling and spacing unit" there are two (2) or more separately owned tracts or there are undivided interests separately owned for which the owners have not agreed to pool their oil and gas interests and to drill and develop the "horizontal drilling and spacing unit" and common sources of supply as a horizontal unit; Applicants have contacted all the respondents herein where their location is known and an effort has been made to reach agreement with these parties; Applicants have drilled or proposes to drill a well on said "horizontal drilling and spacing unit" and to test the common sources of supply and the avoiding of the drilling of unnecessary wells, the prevention of waste and the protection of correlative rights require that the Commission order all owners to pool their interests and to drill and develop the "horizontal drilling and spacing unit" and common sources of supply as a horizontal unit. This horizontal well is part of a requested multiunit horizontal well with Section 6-1S-3W, Carter County, Oklahoma.

3. Legal Authority: Title 52 OKLA. STAT. §87.1.; Spacing Order to issue in Cause CD No. 201903484.

4. Relief Sought

a. Applicants request that the Commission pool the interests and adjudicate the rights and equities of oil and gas owners in the Caney, Sycamore and Woodford common sources of supply underlying a 640-acre horizontal drilling and spacing unit comprised of Section 7, Township 1 South, Range 3 West, Carter County, Oklahoma; all to be upon such terms and conditions as are just and reasonable and which will afford all of such owners the opportunity to recover or receive without unnecessary expense their just and fair share of all hydrocarbon substances produced therefrom, and that the Commission make definite provisions for the payment of all actual costs and expenses, not to exceed reasonable costs and expenses of drilling and development, including a reasonable charge for supervision.

b. Applicants may request at the hearing that the order provide that any owner electing an alternative to participation in the well drilled thereunder shall be deemed to have relinquished all of its working interest and right to drill in the horizontal unit and common sources of supply named herein as to such well and any wells drilled subsequent thereto.

c. Applicants may request at the hearing that the Order provide that as to all payments provided for out of proceeds derived from the sale of production as to any owner electing an alternative to participation in the well drilled hereunder, that such royalty proceeds

shall be net royalty proceeds, after deducting therefrom each owner's proportionate part of all taxes and each owner's proportionate part of the actual costs incurred by the Operator, limited however to those deducted by the purchaser or gatherer from the contract price of the oil and gas or other substances sold, in delivering, processing, gathering, dehydrating, or otherwise making such oil and gas or other substances merchantable or marketable from the unit area.

d. Applicants may request at the hearing that in the event a respondent herein creates a subsequently created burden on its interest after the filing date of the application in this Cause, then in the event such respondent elects either the bonus and royalty, fails to elect to participate, elects to participate and fails or refuses to pay the completed well costs or make satisfactory arrangements with the Operator timely, or is deemed to have elected the bonus and royalty, under the initial Unit well, or any subsequent well proposal, that the Order provide that the responsibility to pay for any subsequently created burden shall be the sole responsibility of the respondent under these circumstances and in no event the responsibility of the Applicant/Operator in this Cause.

e. Applicants may request at the hearing that the Order provide that if the Applicant/Operator shall commence operations (making location) at a surface location off the unit prior to the expiration of one (1) year or 365 days from the date of this order, these operations shall be considered as commencing operations under the terms of the Order to issue.

f. Applicants also request that the Commission designate 89 Energy II, LLC or some other party as operator of said horizontal unit.

g. Applicants may request at the hearing that the Order provide Applicants with 365 days from the date of the Order to commence drilling operations.

h. Applicants will request at the hearing that the order recognize that this horizontal well is part of a requested multiunit horizontal well with Section 6-1S-3W, Carter County, Oklahoma.

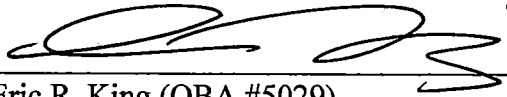
