YOU ARE HEREBY DIRECTED TO APPEAR at the Oklahoma Corporation Commission office, First Floor in the Jim Thorpe State Office Building, 2101 N. Lincoln Blvd, Oklahoma City, Oklahoma, at 8:30 a.m. on the 7<sup>th</sup> day of May, 2021, before an Administrative Law Judge on the Pollution and Enforcement Docket to determine on its merits whether you are responsible for the alleged violation(s) and, if so, why the maximum lawful amount should not be assessed for the alleged violation(s) and an order issued pursuant thereto.

**OAC 165:5-13-3(c) APPEARANCES. EVERY PERSON APPEARING SHALL ENTER HIS APPEARANCE BY STATING HIS NAME AND ADDRESS. THEREAFTER, SUCH PERSON SHALL BE DEEMED A PARTY OF RECORD, UNLESS SPECIFIED OTHERWISE. AN INDIVIDUAL MAY APPEAR ON HIS OWN BEHALF. A CORPORATION MAY APPEAR ONLY BY ITS ATTORNEY; PROVIDED, THAT A REPRESENTATIVE OTHER THAN AN ATTORNEY MAY APPEAR ON BEHALF OF A CORPORATION FOR THE SOLE PURPOSE OF MAKING A STATEMENT OR INDICATING A CORPORATE POLICY. YOU ARE ON NOTICE THAT THE COMMISSION MAY PROCEED TO HEAR EVIDENCE AGAINST YOU AND ENTER SUCH ORDER AS SHALL BE JUSTIFIED BY THE EVIDENCE SHOULD YOU FAIL TO APPEAR AT THE HEARING, RESPOND OR IF A CORPORATION APPEAR WITHOUT AN ATTORNEY.**

**NOTICE IS HEREBY PROVIDED THAT THE APPLICANT MAY SEEK COMPLIANCE AS WELL AS THE MAXIMUM LAWFUL AMOUNT OF FIVE THOUSAND DOLLARS (\$5,000.00) PER VIOLATION PER DAY AS AUTHORIZED BY 52 O.S. SECTION 102 OR AS OTHERWISE SPECIFIED BY LAW. FORFEITURE OF SURETY, OR ITS INCREASE UP TO THE STATUTORY LIMIT, MAY BE REQUESTED PURSUANT TO 52 O.S. SECTION 318.1.**

**UNLESS DISMISSED, FAILURE TO APPEAR AT THE TIME AND PLACE DIRECTED SHALL BE TAKEN AS A CONFESSION AND MAXIMUM LAWFUL AMOUNT ASSESSED. UNLESS DISMISSED, FAILURE TO FILE A RESPONSE ON OR BEFORE YOUR APPEARANCE DATE TO THE COMPLAINT SHALL BE TAKEN AS A CONFESSION AND THE MAXIMUM LAWFUL AMOUNT ASSESSED, INCLUDING BUT NOT LIMITED TO: ONE THOUSAND DOLLARS (\$1,000.00) FOR NON-APPEARANCE, FIVE THOUSAND DOLLARS (\$5,000.00) PER DAY PER VIOLATION; FIVE HUNDRED DOLLARS (\$500.00) FOR THE ADMINISTRATIVE COST OF THIS PROCEEDING; TO DRAW UPON APPLICABLE AND POSTED SURETIES TO PLUG CERTAIN WELL(S); AND TO VACATE ANY ORDER(S) ESTABLISHING THE WELL(S).**
