**Public Comment:** Comments were made and discussions held regarding proposed rules. Written comments filed with the Commission's Court Clerk are summarized in the Rule Report under Section 9. All comments were addressed and taken into account in the adopted rules.

Rule Impact: The persons most likely to be affected by the proposed rules include persons and regulated entities that appear before, and those that submit or file information with the Commission. Although the proposed rules could have an economic impact on entities regulated by the Commission, it is anticipated that the benefits obtained from the updates, increased efficiency, streamlining, and clarifications provided by such rules will outweigh any potential expenses associated with such proposed rules. It is not anticipated that the proposed rules will have an adverse economic impact upon political subdivisions or upon persons or entities regulated by the Commission.

**Reason for Rule:** The adopted rules are necessary to cr eate processes and procedures for the

Pursuant to the Oklahoma Administrative Procedures Act requirements in 75 O.S. §§ 303.1(A) and 308(A), the Oklahoma Corporation Commission ("Commission") hereby respectfully submits this Agency Rule Report to the Honorable J. Kevin Stitt, Governor of the State of Oklahoma, the Honorable Greg Treat, President Pro Tempore of the State Senate, and the Honorable Charles McCall, Speaker of the House of Representatives.

## 6. STATEMENT OF THE GIST OF THE RULES AND BRIEF SUMMARY OF THE CONTENT OF THE ADOPTED RULES:

The adopted rules primarily relate to the forthcoming Electronic Case Filing ("ECF") System, including the authorization for the creation of an ECF User Manual. Additionally, the adopted rules remove the ability to file documents by fax and replace it with the ability to file by electronic mail, clarify the computation of time for periods greater than and less than five days, amend the process for dismissing applications or cases, create a discovery process for proceedings on the OSF (Oklahoma Universal Service Fund) docket, and establish procedures for the Motor Carrier Citation ("MCC") Docket.

#### 7. STATEMENT EXPLAINING THE NEED FOR THE ADOPTED RULES:

The adopted rules are necessary to create processes and procedures for the forthcoming ECF System, explicitly allow for filing of documents by electronic mail, clarify the computation of time for periods greater than and less than five days, amend the process for dismissing applications or cases, create a discovery process for proceedings on the OSF (Oklahoma Universal Service Fund) docket, and establish procedures for the MCC Docket.

## 8. DATE AND LOCATION OF THE HEARING AT WHICH THE RULES WERE ADOPTED:

On March 18, 2021, the rules were adopted in a public hearing held in Courtroom 301, Oklahoma Corporation Commission, Jim Thorpe Office Building, 2101 North Lincoln Boulevard, Oklahoma City, Oklahoma 73105, before the Commission. The public hearing was also held via livestream, teleconference, and videoconference through Scopia to allow for remote participation.

SUMMARY OF COMMENTS AND EXPLANATION OF CHANGES OR LACK OF ANY CHANGES MADE IN THE ADOPTED RULES AS A RESULT OF TESTIMONY RECEIVED AT THE PUBLIC HEARINGS OR MEETINGS HELD OR SPONSORED BY THE AGENCY FOR THE PURPOSE OF PROVIDING THE PUBLIC AN OPPORTUNITY TO COMMENT ON THE RULES OR OF ANY COMMENTS RECEIVED PRIOR TO ADOPTION OF THE RULES:

#### **Summary of Written Comments:**

Written comments were provided by The Petroleum Alliance of Oklahoma. The comments generally supported the concept of using a robust ECF System and requested that the development of the user manual should be an open process, similar to a rulemaking.

#### **Summary of Public Meeting Comments:**

The first Technical Conference was held on February 19, 2021, at 9:30 a.m., at the Oklahoma Corporation Commission, Jim Thorpe Office Building, Courtroom 301, 2101 North Lincoln Boulevard, Oklahoma City, Oklahoma. It was also held via livestream, teleconference, and videoconference through Scopia, to afford the public an opportunity to appear, comment on, and suggest additions and/or revisions to the proposed rules.

During the first Technical Conference, oral comments were provided by a representative of the Oklahoma Attorney General's Office regarding OAC 165:5-1-6. The representative expressed concern about loss of response time when filings are made on weekends or during other

times when the Commission is closed. Commission staff revised its proposal such that when computing periods of time of five (5) calendar days or less, any period of time that would otherwise begin to run on a Saturday, Sunday, or legal holiday or official agency closing will begin to run on the next business day.

Matt Allen provided oral comments regarding OAC 165:5-9-2 and possible dismissal of causes on the Commission's Oil & Gas docket without notice to parties who have sought affirmative relief. In consideration of this concern, the proposed rule was revised to state that dismissal shall not dismiss the cause as to specifically stated affirmative relief. The proposal was further revised to state that a respondent requesting affirmative relief may pursue such relief by presenting evidence and may be granted any relief which an Administrative Law Judge or the Commission deems appropriate.

The second Technical Conference was held on March 4, 2021, at 9:30 a.m., at the Oklahoma Corporation Commission, Jim Thorpe Office Building, Courtroom 301, 2101 North Lincoln Boulevard, Oklahoma City, Oklahoma. It was also held via livestream, teleconference, and videoconference through Scopia, to afford the public an opportunity to appear, comment on, and suggest additions and/or revisions to the proposed rules.

During the second Technical Conference, oral comments were provided by Bill Bullard on OAC 165:5-1-5(d) regarding disputing the authenticity of electronic signatures and objecting thereto. Mr. Bullard suggested that "may" be replaced by "shall" in the proposed rule to make clear that filing an objection is the only means of disputing authenticity. Commission staff explained that permissive language is used in the proposed rule because the filing of an objection is not mandatory. It is required only if a person wishes to formally dispute the authenticity of an electronic signature.

Mr. Bullard also provided oral comments on OAC 165:5-1-5(h), which proposes that confidential documents not be electronically filed, but rather that such documents be mailed or provided in person to the Commission's Court Clerk within one (1) business day of the electronic filing of the cover page. Mr. Bullard's comment sought confirmation that confidential documents postmarked within one (1) business day of filing the cover page would be acceptable. Commission staff confirmed that this would be acceptable submission of confidential documents pursuant to the proposed rule.

Mr. Bullard also provided oral comments on OAC 165:5-1-12.1 by asking for clarification of the meaning of the "completion of filing" language. Commission staff explained that where a filing fee applies, a filing is not complete until proper payment has been received by the Commission.

Mr. Bullard provided oral comments on OAC 165:5-1-14.1. The proposed rule provides that service of notice through the ECF System is not effective if the person attempting service receives notice from the ECF System that the attempted service was not electronically delivered to the person to be served. Mr. Bullard inquired as to what should be done if the ECF System informs a person that attempted service was unsuccessful. Commission staff explained that service

would need to be accomplished by other means available pursuant to the Commission rules or by statute to be deemed effective.

A public hearing took place before the Commission on March 18, 2021, at 9:30 a.m., at the Oklahoma Corporation Commission, Jim Thorpe Office Building, Courtroom 301, 2101 North Lincoln Boulevard, Oklahoma City, Oklahoma. It was also held via livestream, teleconference, and videoconference through Scopia to afford the public an opportunity to make oral comments concerning the revised proposed rules.

During the public meeting, oral comments were provided by Howard L. (Bud) Ground of The Petroleum Alliance of Oklahoma. Mr. Ground stated support for the proposed rules, while urging that development and any changes to the user manual associated with the proposed rules should be made in a setting similar to a rulemaking.

The Commission considered the proposed rules filed on March 16, 2021. After acknowledging all written and oral comments, a majority of the Commission voted to approve the proposed rules filed on March 16, 2021, with the exception of OAC 165:5-7-53(d), which the majority voted to strike from the proposed rules. Oral comments were provided at the hearing by Commissioner Dana L.
