APPLICATION

I. APPLICANT: Public Service Company of Oklahoma (“PSO”)
212 East Sixth Street
Tulsa, Oklahoma 74119-1212

II. ALLEGATIONS OF FACT:

(a) PSO is an Oklahoma corporation with its principal office and place of business at 212 East Sixth Street, Tulsa, Oklahoma 74119-1212. PSO is engaged, generally, in the business of generating, purchasing, transmitting, distributing and selling electric energy in the State of Oklahoma. PSO's Oklahoma operations are subject to the jurisdiction of the Oklahoma Corporation Commission.

(b) On March 16, 2021, PSO filed a Notice of Intent pursuant to OAC 165:70-3-7.

(c) PSO brings this Application to initiate a proceeding to review PSO's rates, charges, regulations and conditions of service and for the establishment of fair and reasonable rates and charges. This rate case is required by the terms of a Joint Stipulation and Settlement Agreement approved by Order No. 692809 issued March 14, 2019, in cause PUD No. 201800097, wherein PSO was required to file a base rate no earlier than October of 2020 and no later than October of 2021.

(d) The specifics of PSO's requests are set forth in the testimony and exhibits filed pursuant to this Commission's Minimum Standard Filing Requirements found at OAC 165:70-1-1 et seq., all of which are incorporated herein as if fully set forth.

III. LEGAL AUTHORITY:

Okl. Const. Article 9, Section 18; 17 O.S. § 152, 153, 250 et seq. and 281 et seq.; OAC 165:70-1-1 et seq.; OAC 165:35-1-1 et seq.; and, Order No. 708933.

IV. RELIEF REQUESTED:

WHEREFORE, Public Service Company of Oklahoma requests this Commission to authorize a general rate increase, changes in tariffs and terms and conditions of service, as well as all other relief requested in the testimony and exhibits filed by PSO in this cause.
