JOINT MOTION FOR PROTECTIVE ORDER

Joint Applicants CenterPoint Energy Resources Corp. (“CERC”), Southern Col Midco, LLC (“SC MidCo”), and Summit Utilities Oklahoma, Inc. (“SUO”), for their Joint Motion for Protective Order state as follows:

1. In the course of these proceedings, Joint Applicants may wish to provide or may be asked to produce certain information which is considered confidential and proprietary by CERC, SC Midco, and/or SUO. Without waiving any objection to future requests, Joint Applicants believe that a Protective Order should be issued now to facilitate review of this Cause and to avoid later delay in the discovery process.

2. In order to protect such information from unauthorized disclosure, the Protective Order should cover the following:

a. Information or documents containing the names of individual customers, or from which individual customers could reasonably be identified, and which contain information specific to service to individual customers, individual gas usages or individual prices or other individual material terms associated with the business of either of the Joint Applicants with those customers.

b. Financial information of the private parent and holding companies of SUO that is not available to the public and the disclosure of which would be prejudicial.

Joint Applicants, respectively, reserve the right to seek an amendment to the protective order to cover additional information and materials should such be necessary.

WHEREFORE, Joint Applicants CenterPoint Energy Resources Corp., Southern Col Midco, LLC, and Summit Utilities Oklahoma, Inc. request that the Commission issue a protective order covering the materials described above.
