JOINT MOTION TO ESTABLISH PROCEDURAL SCHEDULE

Joint Applicants CenterPoint Energy Resources Corp. (“CERC”), Southern Col Midco, LLC (“SC MidCo”), and Summit Utilities Oklahoma, Inc. (“SUO”), for their Joint Motion to Establish Procedural Schedule state as follows:

1. CERC, SC MidCo, and SUO have filed a Joint Application under OAC 165:45-3-5 requesting that the Commission issue an order approving the transfer of specified utility assets and customer accounts from CERC to SUO.

2. Applicable rules of this Commission specify a hearing date for a Cause such as this should be commenced “within sixty (60) calendar days after the joint application” is filed. OAC 265:45-3-5(e).

3. In order to facilitate the timely processing of this Cause in accordance with OAC 265:45-3-5(e), Joint Applicants request that the Commission issue an order establishing procedural schedule providing for the commencement of a hearing within sixty (60) calendar days, as required by the rule.
