2. Facts:

a. By Order No. 669738, the Commission formed 640-acre horizontal drilling and spacing units underlying Section 4, Township 5 North, Range 4 West, McClain County, Oklahoma, for the Mississippian and Woodford common sources of supply.

b. By Order No. 680033, the Commission formed 640-acre horizontal drilling and spacing units underlying Section 9, Township 5 North, Range 4 West, McClain County, Oklahoma, for the Sycamore and Woodford common sources of supply.

c. By Order No. 681187, the Commission formed 640-acre horizontal drilling and spacing units underlying Section 16, Township 5 North, Range 4 West, McClain County, Oklahoma, for the Sycamore and Woodford common sources of supply.

d. The Woodford common source of supply in Sections 4, 9 and 16 is the target interval found at an approximate depth of 11,210 feet. The Mississippian/Sycamore common source of supply in Sections 4, 9 and 16 is an adjacent common source of supply found at an approximate depth of 11,039 feet.

e. Applicant is proposing to drill a multiunit horizontal well in the lands involved herein, with a portion of the completion interval of such multiunit horizontal well to be located in one or more of the 640-acre horizontal drilling and spacing units formed for the applicable separate common sources of supply involved herein in said Sections 4, 9 and 16. Applicant is proposing to drill the multiunit horizontal well involved herein from the following:

Completion Interval in Section 4-5N-4W, McClain County, Oklahoma:

First Perforation: Not closer than 2,640 feet from the North line and not closer than 1,320 feet from the West line of Section 4, Township 5 North, Range 4 West, McClain County, Oklahoma.

Last Perforation: Not closer than 0 feet from the South line and not closer than 1,320 feet from the West line of Section 4, Township 5 North, Range 4 West, McClain County, Oklahoma.

Completion Interval in Section 9-5N-4W, McClain County, Oklahoma:

First Perforation: Not closer than 0 feet from the North line and not closer than 1,320 feet from the West line of Section 9, Township 5 North, Range 4 West, McClain County, Oklahoma.

Last Perforation: Not closer than 0 feet from the South line and not closer than 1,320 feet from the West line of Section 9, Township 5 North, Range 4 West, McClain County, Oklahoma.

Completion Interval in Section 16-5N-4W, McClain County, Oklahoma:

First Perforation: Not closer than 0 feet from the North line and not closer than 1,320 feet from the West line of Section 16, Township 5 North, Range 4 West, McClain County, Oklahoma.

Last Perforation: Not closer than 2,640 feet from the South line and not closer than 1,320 feet from the West line of Section 16, Township 5 North, Range 4 West, McClain County, Oklahoma.

and to complete such multiunit horizontal well in and to produce hydrocarbons from the separate common sources of supply involved herein. Applicant is intending to file before the Commission applications requesting the Commission to enter orders granting exceptions to the permitted well location tolerances in the drilling and spacing units involved herein so that the multiunit horizontal well involved herein may be drilled and completed as described above. Applicant intends to run casing in the lateral of the multiunit horizontal well involved herein and to cement such casing so as to cover and isolate the first and last perforations in such lateral. Therefore, the completion interval of the multiunit horizontal well involved

herein will be from the first perforation to the last perforation in the lateral of such well. Applicant is proposing to drill the multiunit horizontal well involved herein with a completion interval in such multiunit horizontal well of approximately 9,700 feet. The proposed multiunit horizontal well involved herein will prevent waste, will protect correlative rights, and will aid in the full and efficient development of each of the affected units covered hereby.

f. The Commission should allocate to each of the affected units covered hereby the reasonable drilling, completion and production costs associated with the multiunit horizontal well involved herein and the commingled production and proceeds from the completion interval of such multiunit horizontal well. Based upon the information now available, Applicant is proposing that the allocation factor for each of the affected units involved herein should be determined by dividing the length of the completion interval of the multiunit horizontal well involved herein located in each such affected unit by the entire length of the completion interval of such multiunit horizontal well. In the event the lateral of the multiunit horizontal well involved herein stays within the productive portion of the Woodford common source of supply throughout the drilling of such lateral, then Applicant anticipates that approximately 25% of the completion interval of such multiunit horizontal well will be located in said Section 4, approximately 50% of such completion interval will be located in said Section 9, and approximately 25% of such completion interval will be located in said Section 16, with the cost of and the production and proceeds from such multiunit horizontal well to be allocated between the affected units involved herein based on such percentages. The actual allocation of such costs, production and proceeds may vary depending upon the results of the multiunit horizontal well involved herein.

g. Attached hereto as Exhibit "B" and made a part hereof is a Production Map on the lands covered by the Application and adjoining lands.

h. In order to prevent waste, to protect correlative rights and to aid in the full and efficient development of each of the affected units covered hereby, the Commission should approve the multiunit horizontal well involved herein, including establishing the applicable allocation factor for allocating the cost of and the production and proceeds from such multiunit horizontal well to each of the affected units covered hereby.

3. Legal Authority: The relief sought by this application is authorized by 52 O.S. §87.6 et seq., and OAC 165:5-7-6.2 and OAC 165:10-3-28.

4. Relief Sought: Applicant requests the Corporation Commission of Oklahoma to enter an order, to be effective as of the date of the execution thereof or as of a date prior thereto, as follows:

- (i) Approving a multiunit horizontal well in the 640-acre horizontal drilling and spacing units formed for the Mississippian and Woodford separate common sources of supply in Section 4, Township 5 North, Range 4 West, McClain County, Oklahoma, and in the 640-acre horizontal drilling and spacing units formed for the Sycamore and Woodford separate common sources of supply in Section

9, Township 5 North, Range 4 West,  
McClain County, Oklahoma, and in  
the 640-acre horizontal drilling and  
spacing units formed for the

16, Township 5 North, Range 4 West,  
McClain County, Oklahoma, so as to  
allow such multiunit horizontal well  
to be drilled as described herein and  
to be completed in and to produce  
hydrocarbons from the above-named  
separate common sources of supply,  
and establishing of a proper allocation  
factor for allocating the cost of and  
the production and proceeds from  
such multiunit horizontal well to each  
of the affected units covered hereby;  
and

(ii) Granting such other and further relief as  
may be proper based upon the evidence  
presented at the hearing herein.

WHEREFORE, Applicant prays that, after notice and hearing as required, the relief sought be granted.


