APPLICATION

1. **Parties:** Applicant, Montclair Energy, LLC, 1800 Canyon Park Circle, Suite 405, Edmond, Oklahoma 73013, Telephone: (405) 341-8822, is the owner of the right to drill a well into and produce hydrocarbons from the hereinafter named separate common sources of supply underlying the captioned lands. The Attorney for Applicant is John E. Lee, III, Wright, Hartsfield & Egbert, P.L.L.C., 1800 Canyon Park Circle, Suite 201, Edmond, Oklahoma 73013, Telephone: (405) 844-7000. The parties being named as respondents to this Application are listed on Exhibit "A" attached hereto and made a part hereof.

2. **Allegation of Facts:**

2.1 Order No. 598905 dated June 20, 2012, established Section 9, Township 13 North, Range 5 East, Lincoln County, Oklahoma, as a 640-acre drilling and spacing unit for the production of oil and gas from the Mississippian, Woodford, and Hunton common sources of supply.

2.2 Heretofore, one (1) well has been drilled and completed in Section 9, Township 13 North, Range 5 East, Lincoln County, Oklahoma, namely the Kauri Cliffs No. 1-19H, which well was drilled to a sufficient depth to test and produce hydrocarbons from the Hunton separate common source of supply, but which well will not drain all of the recoverable hydrocarbons in the Hunton common source of supply underlying the subject drilling and spacing unit. As a result, Applicant requests that the Commission issue an Order approving increasing the well density in this drilling and spacing unit by the drilling of one (1) additional Hunton well to be located in Section 9, Township 13 North, Range 5 East, Lincoln County, Oklahoma. Further, that the Applicant herein shall request that the Order granting the relief requested shall be effective the date of the hearing on the merits of this case.

2.3 To aid in the maximum, ultimate, and effective recovery of hydrocarbons from the separate common source(s) of supply cited hereinabove to avoid waste and protect correlative rights, the Order requested should be issued.
