COMES NOW APPLICANT and shows the Honorable Corporation Commission as follows:

1. Parties: Applicant is Newfield Exploration Mid-Continent Inc., One Williams Center, Suite 1900, Tulsa, Oklahoma 74172, who is the owner of oil and gas leasehold interests within the lands described in the caption hereof. The parties being named as respondents to this Application are listed on Exhibit "A" attached hereto and made a part hereof.

2. Allegation of Facts:

a. That this Commission by **Order No. 612875** established a 640-acre drilling and spacing unit for the production of oil and gas or gas and gas condensate from the **Woodford** common source of supply underlying Section 16, Township 3 North, Range 4 West, Garvin County, Oklahoma; that Applicant herein is the owner of oil and gas leases underlying Section 16, Township 3 North, Range 4 West, Garvin County, Oklahoma; that there is currently one well producing from the **Woodford** common source of supply and it is the opinion of the Applicant that the current well is incapable of draining all of the producible hydrocarbons underlying the drilling and spacing unit and Applicant requests that it be allowed to increase the well density in said unit by the drilling of **five additional wells** to be located in Section 16; that the **five additional wells** requested by Applicant are necessary to effectively and efficiently drain a portion of the common source of supply (reservoir) covered by the drilling and spacing (proration) unit which cannot be effectively and efficiently drained by any existing well within the drilling and spacing (proration) unit.

b. Applicant has conducted a diligent and meaningful search of the local county assessor's records, county treasurer's records, and county deed records regarding the property involved for return addresses on recorded instruments, county probate records and city and county telephone directories and other sources of such information to locate each respondent.




