COMES NOW the Applicant, Continental Resources, Inc., and shows the Honorable Corporation Commission the following:

1. PARTIES:

1.1 Applicant is: Continental Resources, Inc.
P.O. Box 269091
Oklahoma City, OK 73126

Applicant is the owner of the right to drill a horizontal well to the common source(s) of supply named below underlying the lands described in the caption hereof.

1.2 Respondents are set out on the Exhibit "A" attached hereto and made a part hereof.

2. ALLEGATION OF FACTS:

2.1 Rule 165: 10-3-25 requires that a completion report shall be filed with the Commission on Form 1002A within thirty (30) days after completion operations regardless of whether or not the well is completed as a dry hole, producer, injection, disposal or service well.

2.2 Rule 165: 10-17-6(b) requires that the operator of a well shall be responsible for testing the well by determining the calculated wellhead absolute open flow potential of the well determined by obtaining a static column wellhead flowing pressure and shall indicate the capacity of the well to produce against zero psi at the wellhead. The Operator of the well shall be responsible for filing with the Conservation Division Form 1016.

2.3 Applicant fully intends to comply with the above cited rules.

2.4 The name of the well in the unit described in the caption is the Eichelberger well. The well has been drilled and completed. A number of parties are seeking well information from this well prior to making their election as to whether to participate in the well or not.

2.5 Applicant is requesting that the Form 1002A and Form 1016 be afforded confidential treatment by this Commission, similar in manner to well logs, for a period of time to be determined at the hearing on the merits of this case. Applicant is representing to the Commission that the time period be based on reasonable estimates of when the disputed cases may be resolved.

2.6 Applicant is requesting confidential treatment relief be afforded as an exception to each of the rules described above.

2.7 Applicant believes that granting an exception to the above named rules clearly is in the interest of the protection of correlative rights of the participating parties in particular of the Applicant in this case.

3. LEGAL AUTHORITY: Title 52 O.S. 1971, §87.1.






