Box 722348, Norman, Oklahoma, 73070-8777, Operator No. 17663-0, to SandRidge Exploration and Production, LLC, Operator No. 22281-0, only insofar as subsequent wells to be drilled under the described Pooling Order.
6. Reason for Relief: The Applicant has acquired interest from the Operator designated under Pooling Order No. 376241 insofar as development outside existing wellbores. Applicant is proposing additional development on the drilling and spacing unit.
7. Relief Granted: The requested relief is granted. Pooling Order No. 376241 (September 2nd, 1993) should be modified to replace MJM Resources, Inc. with SandRidge Exploration and Production, LLC only insofar as subsequent wells to be drilled under the described Pooling Order.
