
## MULTIPLE/MASS TRANSFER

- CHECK PRINTOUT, WE PREFER YOU USE OUR PRINTOUT. ANY WELLS THAT ARE NOT ON OUR DATA BASE CANNOT BE TRANSFERRED AS A MULTIPLE/MASS. CHECK LIST TO MAKE SURE ALL WELLS ON THE LIST ARE TO BE TRANSFERRED. IF YOU DO YOUR OWN LIST IT NEEDS TO BE IN NUMERICAL ORDER.
- MAKE SURE THAT WELLS SHOWING TM (TERMINATED) INJECTION/DISPOSAL WELL) ARE CHECKED FOR AMENDED 1002A TO SHOW THE CURRENT CLASSIFICATION. IF THERE IS NONE SEND AN ORIGINAL WITH THE TRANSFER. IF THERE IS ONE SEND A COPY.
- ACTIVE INJECTION/DISPOSAL WELLS ARE TO BE MARKED OFF THIS LIST. WE DO NOT TRANSFER THEM IN WELL RECORDS. 2D MEANS THAT THE WELL IS A DISPOSAL AND 2R MEANS THE WELL IS AN INJECTOR.
- **WELLS THAT SHOW ND (NEW DRILL) WILL REQUIRE AN AMENDED ITD (INTENT TO DRILL) TO CHANGE OPERATOR. IF THE WELL HAS A SPUD (STARTED DRILLING) THEN WE WILL TRANSFER IT. YOU WILL NEED TO SEND IN A 1002A (COMPLETION RECORD) WITHIN 30 DAYS OF COMPLETION.**

- WE WILL ALSO REQUIRE A COVER SHEET WITH A CONTACT PERSON FROM THE CURRENT AND THE NEW OPERATOR.
- THE NEW OPERATOR & CURRENT OPERATOR WILL PLEASE SIGN THEIR RESPECTIVE COPY OF THESE INSTRUCTIONS. PLEASE RETURN COPIES WITH THE PRINTOUT. WITH ATTENTION TO ME ON THE ENVELOPE.
