Continental Well Location Plat

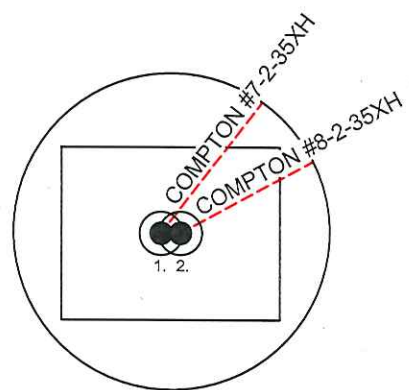
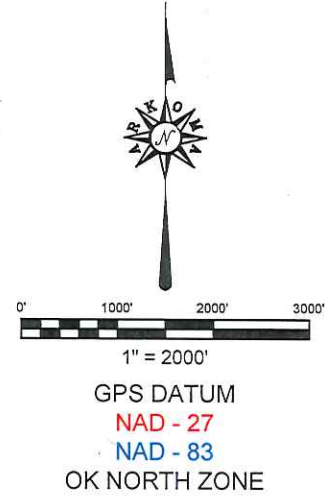
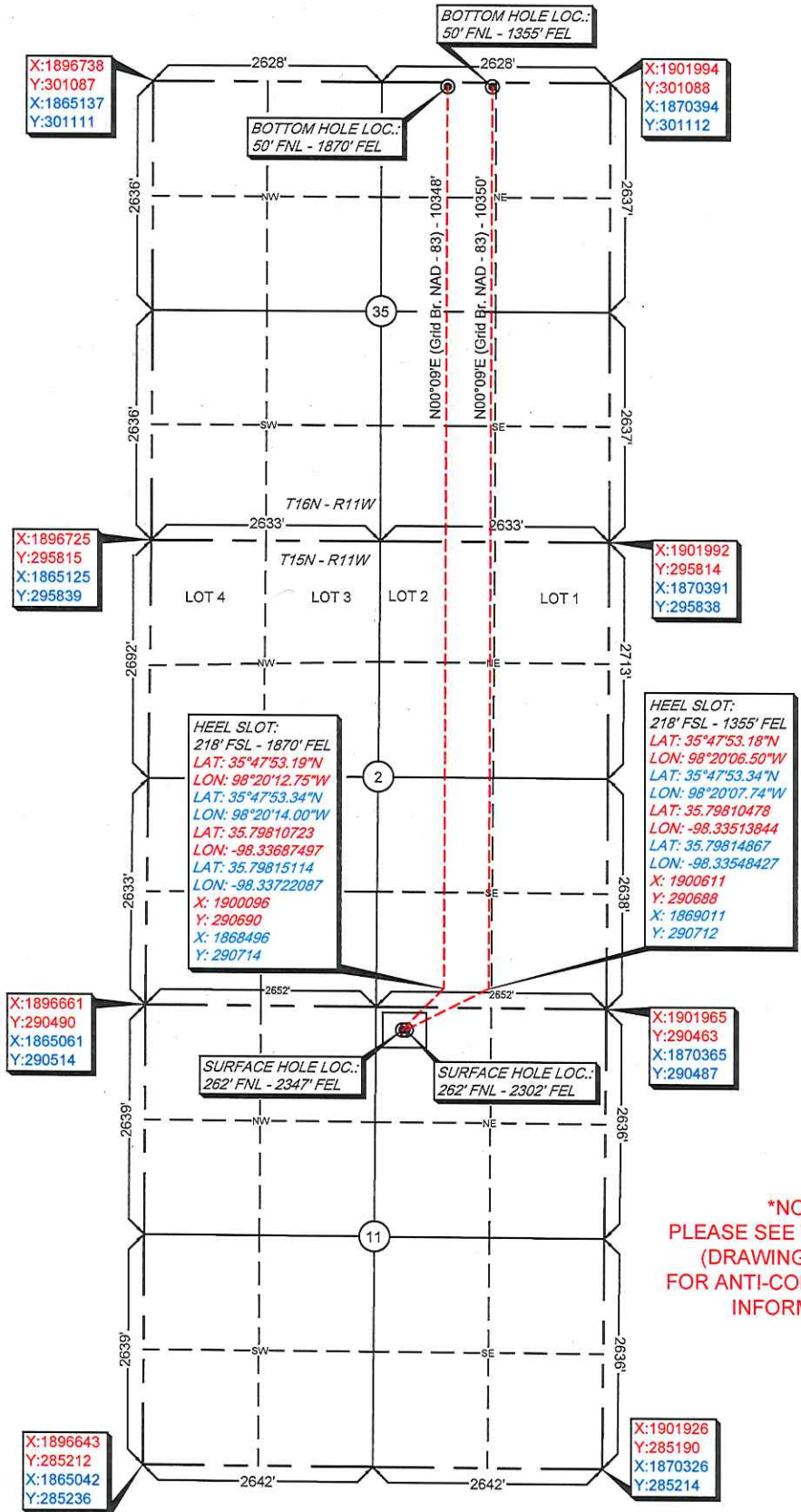

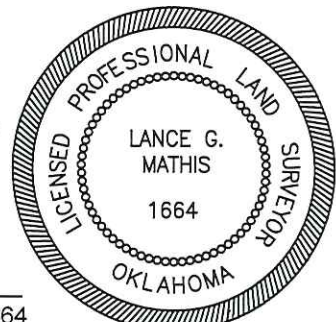
