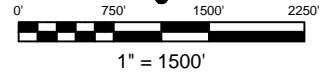
Calyx Energy LLC Well Location Plat

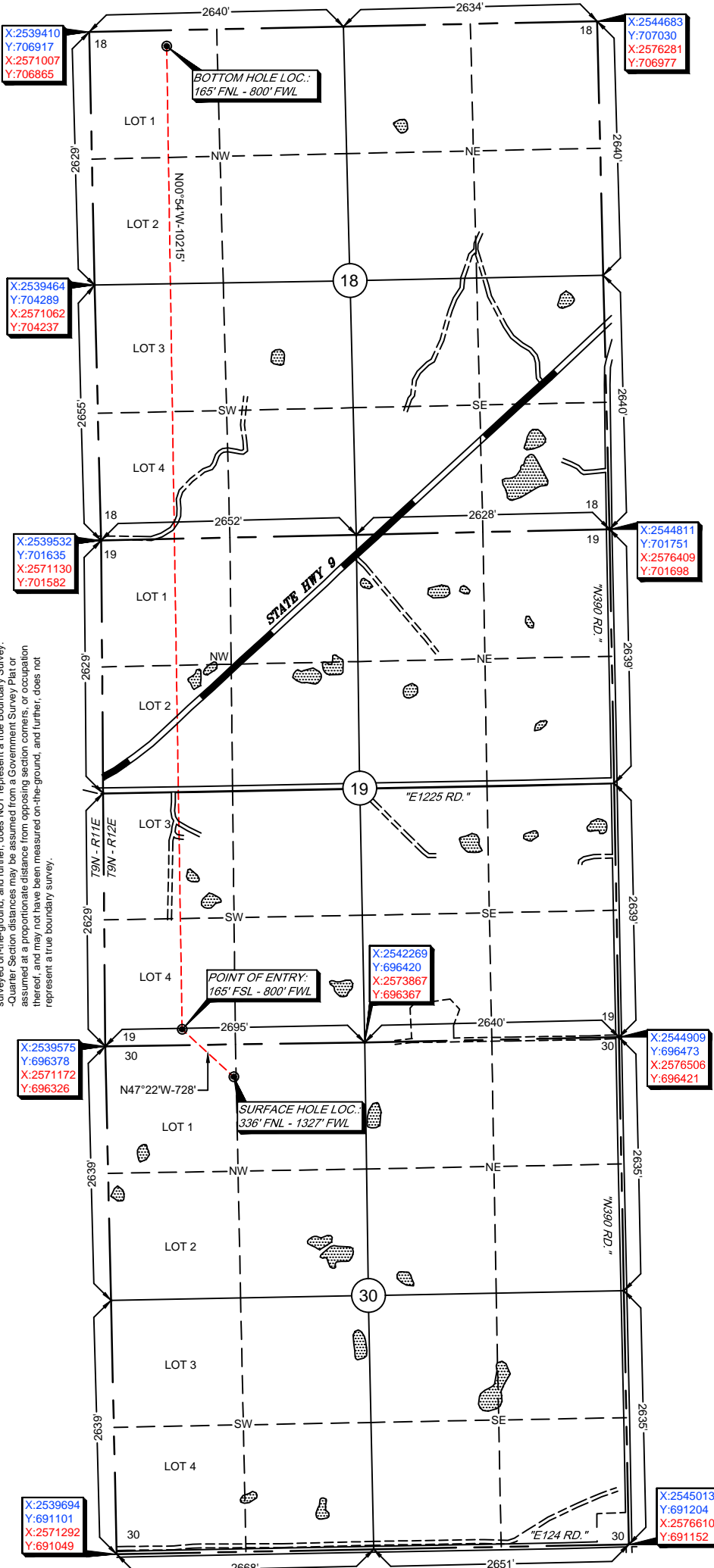
